This is to inform all students of NIT Silchar that the **Debate** for the **Gymkhana Elections 2025** will be held as per the schedule below:


- **Date:** 07 August 2025

Rules and Regulations of Debate for Gymkhana Election-2025

The rules and regulation of the Debate to be organized for the contestants for the post of VP and GS(s) of the Gymkhana Election 2025 of NIT Silchar are as follows:

General Rules and Regulations

Objective

The Debate Session is organized to provide a fair platform to all the eligible candidates contesting for Gymkhana Election 2025 to present their vision, address student concerns, and respond to questions from moderators and the audience.

Eligibility

- Only official contesting candidates for the posts of **Vice President and General Secretary(s)** (Sl.No. 1-5 as per notification published earlier) nominated for the Gymkhana Election 2025 are allowed to participate in the debate.
- Candidates must be present in person. No proxies or video representations allowed unless approved for medical or valid reasons by the Returning Officer.

Format

The debate will be conducted offline at a specified venue mentioned.
A panel of moderators will conduct the debate.

Each candidate will have:

- Opening Speech: 3 minutes
- Vision Presentation: 4 minutes
- Q&A Round: Moderator and audience questions – max 3 minutes
- Rebuttal Round (if applicable): 1 minute per rebuttal
- Closing Statement: 1 minute

Conduct and Decorum

- Use of abusive, defamatory, communal, casteist, or personal remarks is strictly prohibited.
- No candidate shall interrupt another candidate's speech.
- Disruption of proceedings will lead to warning and possible disqualification.
- Candidates must not display party symbols, posters, or any promotional material during the debate.
- Use of electronic devices (mobile, tablet, etc.) during the debate is prohibited unless permitted by moderators.
- Any comment/remarks which may affect the training and placement, and institutional perception to the outside world ARE STRICTLY PROHIBITED. Violation may attract disqualification of candidature.
- Audience is instructed to maintain decorum during the entire proceeding of the debate. Students found in any misconduct/ unruly behaviour shall be liable for the cancellation of voting right in Gymkhana Election 2025.

Questions

Questions may be posed by:

- The moderator panel.
- Other candidates, during the rebuttal round
- Audience members
- No personal questions or false allegations will be entertained.
- The moderator has the right to filter or reject any question.

Time Management

- Time limits will be strictly enforced. Candidates exceeding time may be muted or stopped.
- A timekeeper will signal remaining time:

Moderation

The moderator panel reserves the right to:

- Mute or stop a speaker
- Issue warnings
- Disqualify a candidate from the debate in case of serious violation
- Moderator decisions are final and binding.

Recording & Broadcasting

- The debate will be recorded and may be live-streamed on official platforms.
- Candidates must consent to the recording and agree not to edit or misuse debate footage for campaign purposes.

Code of Ethics

- All candidates must adhere to the Election Code of Conduct as laid down by the NIT Silchar Gymkhana Election Commission.

Any breach may lead to disciplinary action, including disqualification from the election.

Miscellaneous

- In case of emergency, the debate may be rescheduled or modified.
- All participants must arrive 30 minutes before the scheduled time for verification.

President of Gymkhana, Associate Dean(s) (SW), all Wardens and Assistant Wardens will act as the moderator(s) of the debate.
